MINUTES

I. OPENING:

II. STAFF UPDATE:

The community Broadband Survey update that was presented to the Mathews County Board of Supervisors was shared with the group. It was noted there were 1,220 survey respondents, and those households/businesses using DSL or satellite will benefit most from our efforts. Judy noted the full CIT insight is on the County's website, and questions were addressed from new members about tower locations. Bill Vrooman asked if the group should consider a hybrid service when writing grants. Also noted was a Gazette-Journal article that talks about the decline in Mathews County Public Schools enrollment, and the lack of Internet service in some areas as a contributing factor.
