MINUTES: Approved as emailed with one correction.

OLD BUSINESS

Breezeline: All projects turned over to marketing. Total connected: 210. **OpenBroadband:** VATI Grant Project, Joe out of the country. Greg Reid: Tarranna equipment is here. When climbers will take down and put-up new in the same climb. Downtown service from OBB not good. Jeff will check on.

Marj Terry asked about service outside from the towers.

Towers: RFPs have gone out for 30 days, deadline is end of August *(15 September.) Correction.*

Website: Page - needs more content. Waiting to update logo.

Permits: James and Ramona not in the meeting.

Reviewed Affordable Connectivity Program (ACP), especially with Dr. Daniels, new MCPS Superintendent. He will help us to get the information out again to students and their parents.

Willie asked about Dominion getting power to the two towers. Question to go to Ramona and Jon Mohr.

NEW BUSINESS

Towers: RFPs for cellular and for wireless. Will help with telehealth and public safety. Looking for bringing fiber backhaul To Mathews.

Next Projects: Jeff - BEAD \$1.48M and VAT'i Funding. Wireless providers are not qualifying unless they can provide licensed frequencies. Towers have four places for providers: three cellular and one fixed wireless.

Conversations with Breezeline about another possible VATI Grant with Middlesex and Lancaster. They are asking us to provide coverage through some other company for the households that they do not want to reach. Judy: "Breezeline has created their own nightmare by cherry picking all over the county. Now they have a mess to clean up."

PRESENTATION:

Verizon Proposal; Judy introduced the presenters that she met at the Providers Conference in Richmond:

Tom Walls, Verizon Director of State and Local Affairs for Virginia and Chris Debosier, Verizon Executive Director Network Regulatory Team

Proposed \$26M - \$28M Verizon project for universal coverage to Mathews County. Apply for \$18M - \$22M from state with Verizon paying the other 205 -30%. Mathews would pay \$0!

BAB offers to provide in-kind funding. Might not be needed in the BEAD Program.

Dr. Daniels: Possibility to add to the schools? To make a bigger pipe from the 1G they have now. Debosier: Within BEAD there are funds for anchor institutions. Contact state VATI representation about CAI (County Anchor Institutions) They have a very specific pot of money for them. Talk to them. For the county, Verizon would be the applicant for the BEAD funding. For the CAI, MCPS would be the applicant.

Speeds of 300megs down and 300 megs up is 3rd generation, not first. Not a new system.

Enormous cyber security network. Supply chain: Verizon/Corning They have all the fiber they need. At front of the line. Long time commitment to the county.

Willie: It's an end to end solution. Verizon would own the fiber. There would be no need for another provider for the middle mile.

Tom: Verizon was not using subsidies and now will as it can, but will continue on own dime after subsidies are over.

One of them will come to the BOS meeting to present this proposal.
