### **OLD BUSINESS**

Monopole Towers: Jeff reported that Verizon is still working on the environmental requirements for Hudgins. Ramona reported switch over temporary power to electricity at Hudgins will be done soon. Dominion is doing design to bring power to the Bohannon Tower.

### VATI Grant with Gloucester and OBB:

# Verizon Proposal:

Jeff DHCD still working on the final challenges. Application portal should be opening in a few months. Tyler reported on the squabble between NTIA and the states over what to do to replace the ACP. The low cost programs that are required butt up against the concept of a non regulated industry to be dictated a cost by the states. VA wants to leave it up to the ISPs to decide on their own rate.Louisiana has set a rate of \$30

and been approved. To get BEAD funding ISPs have to comply with that. Pearl asked if the governor had weighed on on this. It appears that he wants the ISPs to set their own rates. Marshall asked who will resolve this. The governor has this task.

## **NEW BUSINESS**

Tyler's PowerPoint Presentation: Planning Grant possibility

DHCD has gotten permissions to handle Digital Opportunity Planning Grant program, aka Virginia Affordability and Adoption Planning Grant. It is \$25,000.00 for each locality for planning activities which will make us eligible for a Digital Opportunity Capacity Grant. Open window for applications is the 15th of every month. Tyler will apply by May 15th.

Planning Grants have four components:

- 1. Access: connectivity to residents and access to devices
- 2. Affordability: packages for low-income residents.
- 3. Adoption: education, digital literacy
- 4. Advancement: telehealth, monitoring sea level rise,

Capacity Grants (coming later) can be regional plans, not just for Mathews. The targeted populations include rural, with fits Mathews.. Steps:
